#### From the Director

One of the highlights of my year is celebrating the exceptional work of the dedicated librarians and staff at the Medical Library, as showcased in our annual report. The 2023/2024 Annual Report of the Cushing/Whitney Medical Library highlights the vital services, collections, and expertise we provide to support our diverse constituencies. This year's report also emphasizes the many ways in which the library intersects with the Yale School of Medicine's educational, clinical, research, and diversity strategic plans. By providing free and equitable access to our collections, services, and instructional sessions across Yale New Haven Hospital (YNНН), Yale School of Public Health (YSPH), Yale School of Nursing (YSN), Yale School of Medicine (YSM), and Yale University, the library empowers every community member to reach their full potential. In doing so, we foster a deeper sense of belonging within the University and Medical Center.

To bolster Student Engagement in Gaining Competency in education, our Academic Research & Education Librarians designed and implemented an evidencebased medicine activity for students in the Internal Medicine clerkship, providing formative feedback to enhance their literature searching and evaluation skills. Additionally, our librarians contribute to Faculty Participation in the Education Mission by collaborating with the Center for Medical Education, delivering instruction in the Master of Health Science-MedEd Program, and supporting various fellowship programs that focus on education scholarship for YSM faculty. Six of our librarians serve as affiliates in the new YSM advisory houses, creating informal opportunities for student-librarian engagement and exemplifying how we Build a More Supportive and Enriched Learning Environment.

In alignment with the academic health system's goal to *Deliver Exceptional Quality* 

& Value, our Clinical Research & Education
Librarians conducted expert searches of
biomedical literature to support the development
of the Yale New Haven Health System's (YNHHS)
Care Signature Pathways. To Foster Continuous
Learning & Innovation they have mapped specific
library services, classes, and resources to each
of the six Accreditation Council for Graduate
Medical Education (ACGME) Core Competencies,
creating a pathway for residents to achieve these
milestones.

Supporting YSM's Strategic Investment in Data Science, the Medical Library played a role in the Department of Biomedical Informatics and Data Science's (BIDS) acquisition and launch of the frequently requested Merative MarketScan research databases. Additionally, our Research & Education Librarians for Bioinformatics partnered with the Yale Center for Research Computing and Yale Center for Genomic Analysis to host and teach an immensely successful eight-week training series on RNAsequencing data analysis, which attracted over 300 attendees. In support of Health Equity Research, our medical librarians collaborated with YSM researchers on evidence synthesis projects focused on health equity. They also used their research expertise to directly support the Office of Health Equity Research (OHER) in selecting the recipients of the 2023 OHER Awards for Yale Research Excellence.

I would like to express my profound gratitude to our dedicated library staff, whose hard work and passion make these achievements, and many more, possible. I also want to thank our users for their continued trust and engagement with our services, expertise, and collections. Together, we will continue to advance knowledge, support research, and contribute to the ongoing excellence in health sciences education and practice.

# ONGOING SUPPORT FOR CARE SIGNATURE

YNHHS'S Care Signature Pathways ensure that patients receive the highest standard of care, grounded in the latest evidence. Led by the Head of Clinical Research & Education Zsuzsanna Nemeth, Clinical Research & Education Librarians Alexandria Brackett, Melissa Funaro, and Alyssa Grimshaw play a crucial role in the pathway creation process. They support pathway developers by conducting rigorous searches for high-quality evidence and their findings are instrumental in helping shape clinical consensus, best practices, and point-of-care guidelines impacting nearly two million patients within YNHHS.

Over the past year, the team completed forty literature search packets which informed multiple pathways. They also helped update existing pathways with new evidence. Additionally, the team collaborated with Collections Strategies Librarian Liz Jenkins to secure access to the *Healthcare Administration Database*, which covers a range of topics from hospital administration to public health, plus clinical tools such as *Neurosurgical Atlas* and the *Sanford Guide*.

## YNHH NURSING PROFESSIONAL GOVERNANCE

Clinical Research & Education Librarian for Nursing Janene Batten plays a significant role in supporting nursing practice at YNHH. Janene meets with Nursing Professional Governance councils twice a year plus attends council meetings as requested to provide on-the-spot searching, training, and support. The councils, comprising twenty groups across administrative and service lines, empower bedside nurses with evidence-based literature and standards to ensure optimal patient outcomes.

#### **ACGME CORE COMPETENCIES**

Each summer, Alexandria Brackett, Melissa

Funaro, and Alyssa Grimshaw introduce medical trainees to the vast collection of resources and services available to them at the Medical Library. During orientations, trainees learn how the Medical Library strengthens evidence-based care, improves quality outcomes, and supports a culture of inquiry. This year's orientations solidified this connection by linking library resources and services to the ACGME Core

Competencies. The revised orientation was showcased in presentations at the 2024 Yale Medical Education Day, the Association of College & Research Libraries New England Chapter conference, and the New England Library Instruction Group, providing regional colleagues with examples of how to incorporate core competencies into their own library orientations.

### **Teaching & Collaborations**

#### **BIDS & THE MEDICAL LIBRARY**

The Medical Library continues to enhance its support for biomedical informatics and data sciences, solidifying its role as a key partner in the data-intensive world of healthcare and biomedical research.

The BIDS department, led by Deputy Dean for Biomedical Informatics Lucila Ohno-Machado, collaborated with the Medical Library to develop training for the 'All of Us' Research Program. This National Institutes of Health (NIH) initiative provides registered users with access to health data from participants across the United States. Data Librarian for the Health Sciences Kaitlin Throgmorton and Research & Education Librarians for Bioinformatics Rolando Garcia-Milian and Sofia Fertuzinhos worked closely with BIDS to facilitate Yale researchers' access to, and use of, this robust dataset.

To bolster support for YSM and YNHHS's data-intensive initiatives, the Medical Library has begun recruitment for a Biomedical Informatics Librarian. This new role will support those involved in clinical and healthcare data informatics research and will serve as the primary liaison to BIDS.

#### MERATIVE MARKETSCAN

Additionally, the Medical Library collaborated with BIDS to acquire and



databases, which contain approximately ten billion records of healthcare claims data. Kaitlin Throgmorton played a key role in gathering user needs and consulting on the issues related to large, restricted datasets. 
# NATIONAL CLINICIAN SCHOLARS PROGRAM

Our partnership with the National Clinician Scholars Program at Yale spans at least twenty-five years. This year, the Clinical Research & Education team and Kaitlin Throgmorton delivered four specialized classes to equip scholars with advanced skills in research and data management on top of guidance for evidence synthesis projects. Library support plays a vital role in empowering these scholars to conduct research that advances health equity and addresses critical healthcare disparities. This partnership reflects the Medical Library's commitment to advancing interdisciplinary research and supporting the development of healthcare leaders.

# MIDDLE EAST AND NORTH AFRICA PROGRAM FOR ADVANCED INJURY RESEARCH

Medical librarians partnered with Associate Professor of Emergency Medicine and Medical Library Associates Trustee Hani Mowafi to provide training for participants in the Middle East and North Africa Program for Advanced Injury Research (MENA PAIR) summer session. MENA PAIR is an NIH-supported multi-disciplinary education program hosted by Yale University and the American University of Beirut to enhance injury research capacity.

Alexandria Brackett delivered a presentation on different review types, emphasizing rigorous methodologies and comprehensive search strategies. She also offered individual consultations to review participants' research questions and search



strategies.

Dana Haugh trained attendees on the basics of designing effective graphics and presentations, focusing on readability, organization, and information hierarchy. She concluded with a list of free tools for implementation.

Kaitlin Throgmorton, in collaboration with senior postdoctoral associate Sana Ali, presented a session on research data management. They discussed policies, best practices, strategies, tools, library resources, and offered hands-on activities to reinforce the learning objectives.

#### INTERNATIONAL REACH

Research and Education Librarians for Public Health Kate Nyhan and Kayla Del Biondo collaborated on numerous global projects including an international randomized controlled trial of librarian peer review, a new version of the guide to information retrieval for Campbell Systematic Reviews, and Fogarty Training Grants in Malaysia and Georgia. They also contributed to review papers featuring authors from low- and middle-income countries such as Uganda, South Africa, Ghana, Samoa, and Jordan.

On campus, they taught students how to find scholarly literature and government documents in languages other than English and even used their foreign language skills to answer reference questions. Kaitlin Throgmorton, Sana Ali, Samar Al-Hajj, and Hani Mowafi following a session on research data management for MENA PAIR participants

### EVIDENCE-BASED MENTAL HEALTH CURRICULUM

Melissa Funaro collaborated with Professor of Psychiatry Vinod Srihari to develop a resource guide for the Evidence-Based Mental Health (EBMH) curriculum. This guide provides an overview of relevant journals, instructions for searching for authoritative evidence, and a form for residents to request articles to appraise and present at EBMH seminars.

Over the past year, the guide has been viewed over 300 times and will soon be migrated to an online learning environment to reach a wider audience.

#### YSM ADVISORY HOUSE AFFILIATES

In November, six medical librarians were invited by Associate Dean of Student Affairs John Francis to serve as affiliates in each of the new YSM advisory houses. This invitation was particularly meaningful as it identified librarians as integral members of the student support network and important contributors to a student's success and sense of belonging at YSM. Librarians serving as advisory house affiliates are Courtney Hadley (Creed), Liz Jenkins (Hamburg), Dana Haugh (Yan), Caitlin Meyer (Slayman), Megan Nance (Horstmann), and Judy Spak (Palade).

#### **CURRICULAR INTEGRATION**

Librarian curricular integration across the medical campus expanded significantly this year. Illustrative examples include Janene Batten's involvement in YSN's master's and doctoral curriculum and Research & Education Librarian Caitlin Meyer's twenty hours of instruction in the Physician Associate research curriculum.

In addition to traditional topics such as evidence-based searching and citation management, Kate Nyhan debuted a new lecture on large language models and artificial intelligence (AI) that helped public health students define key terminology,

articulate effective use cases for AI, and understand the potential shortcomings of these emerging technologies.

Head of the Historical Library Melissa Grafe, Archivist Katherine Isham, Curator for Visual Arts Laura Phillips, Library Services Assistant Chris Zollo, and Cushing Center Coordinator Terry Dagradi continued expanding Medical Historical education programs, leading nearly sixty classes this year. Topics included eugenics in psychiatry and pediatrics, history of art and science, medical humanities, and current topics in science and medicine.

# STUDENT RESOURCE SATISFACTION SURVEY

Head of Academic Research & Education Judy Spak, Holly Grossetta Nardini, and Research & Education Librarian Courtney Hadley conducted a survey of YSM students to learn about their preferences for board review materials and third-party study tools licensed by the Medical Library. The results showed that students across all years use a variety of resources to support their learning styles and consider these tools indispensable for preparing for USMLE Steps 1 and 2 CK. Judy and Courtney shared these results with the medical campus community in a poster at Medical Education Day.

#### **NEW RESOURCES**

The Medical Library added several new resources in 2024, carefully negotiated by Liz Jenkins. New journal titles include *The* Lancet Neurology, The Lancet Respiratory Medicine, The Lancet Rheumatology, Journal of Correctional Health Care, Cannabis and Cannabinoid Research, and NEJM AI, a new journal exploring the application of AI and machine learning in clinical medicine. New public health resources include *The* Oxford Research Encyclopedia of Global Public Health which provides peer-reviewed topic summaries related to global public health, and Public Health and Social Care on the Policy Commons platform, which offers access to hard-to-find grey literature.

Additionally, Library Services Assistants Jeff Brown and Lisa Sanders purchased hundreds of items requested by library users for our permanent collection. These requests were made through our 'Suggest a Purchase' form located on our website. In most cases, Jeff and Lisa were able to acquire the materials within just a few days of the request.

# CAREER HIGH SCHOOL PARTNERSHIP

Head of Access & Delivery Services Megan Nance and Courtney Hadley collaborated with Hill Regional Career High School Media Specialist Marilyn Willson and New Haven Public School Library Media Specialist Lead Kim Rogers to plan outreach to Career High School's health and sciences students. This work was seeded by a \$2,000 collection equity award secured by Megan and Holly Grossetta Nardini in 2022 from the National Network of Libraries of Medicine Region 7. The award helped establish a graphic medicine collection in the Medical Library and provided a robust starter collection for the high school.

To deepen the connection between local students and the Medical Library, Megan and Holly visited Career High School to discuss the advantages of reading graphic medicine, and the significance of art and comics within the field of health sciences. At the Medical Library, Megan created inviting displays of the books and Courtney is spearheading a graphic medicine book club.

#### **INTERLIBRARY LOAN**

Though most libraries have a robust in-house collection, it is impossible to own everything. Therefore, libraries rely on a service known as interlibrary loan to borrow from and lend to each other. It's a cost-effective and crucial way of augmenting access to resources and, importantly,

meeting the needs of library users. This year, the Access and Delivery Services (ADS) team borrowed 6,579 items from other libraries for Medical Library users, and loaned 2,304 items. The team worked quickly to ensure that users had prompt access to requested content, averaging a one-day turnaround for most requests. Library Services Assistants Mary Hughes, Dorota Peglow, Vasean Daniels, Vermetha Polite, and Victoria Helwig also partnered with medical librarians to acquire materials needed in support of evidence synthesis projects.

#### **IMPROVING ACCESS**

ADS team members focused on making physical materials in the collection more accessible. Densely packed shelves and items placed on high or low shelves can be difficult for users to locate and reach. The ADS team worked to relocate crowded and out-of-reach items so that all users can more easily access the resources in our collection. In addition to addressing physical barriers within the stacks, Library Services Assistant

Kyra Walker continues to increase the visibility of newly acquired items through the 'New Books' web series on the Medical Library's website. The series surfaces newly added titles from the library catalog, making it easy for users to stay current on the library's collections.

#### **PAMPHLETS AND EPHEMERA**

Katherine Isham continued to improve access to the Medical Historical Library's collections by organizing and creating detailed records for pamphlets and ephemera. These collections contain material related to medicine and public health, and are popular with instructors and researchers.

One such collection is a unique series of health pamphlets issued by Metropolitan Life and other insurance companies from 1875–1978. These pamphlets address children's health, citizenship, dental care, disease, first aid, longevity, nutrition, sanitation, profiles on notable figures in healthcare, and include illustrations and colorful cover art.



# SPECIAL COLLECTIONS ACQUISITIONS

The Medical Historical Library maintains an array of astral holdings, from the print ephemerides (tables of astronomical trajectories) of the mathematician Johannes Regiomontanus (1436-76) to the first telescopic portraits of the moon by Galileo Galilei (1564–1642). Building on this foundation, we purchased the Pelerin manuscript (ca.1811-1814), an illustrated scientific book from the late Enlightenment. The manuscript combines scientific observation with artistry and documents celestial data such as constellations, comets, and lunar topography. This one manuscript reflects and complements the full range of artifacts archived at the Medical Historical Library, such as the Edward C. Streeter Collection of Weights and Measures. It also supports new thinking about the histories of astronomy, astrology, mathematics, medicine, and metrology that intersect

within the collection.

The Historical Library also acquired an elaborate, nineteenth-century student notebook created in London featuring intricate anatomical drawings that include paper flaps of different layers of the human body. Fold-out charts document in-depth studies of anatomy, pharmacology, and medical diagnosis.

### New at the Library

#### **JOURNALS WITH APC WAIVERS**

Yale Library supports authors publishing in open access journals by providing article processing charge (APC) waivers and discounts. Thanks to a combination of three library-subsidized APC models, Yale authors can make their research publicly available in over 700 journals for little or no cost. To help authors on the medical campus locate potential journals, Kate Nyhan, Alexandria Brackett, Dana Haugh, and Victoria Helwig developed a webpage featuring 180 journals relevant to the medical campus in which Yale authors can publish open access articles for free. Since its launch in October 2023, the webpage has been viewed over 1,200 times, demonstrating both its value as a resource and a growing interest in publishing research without paywalls.

#### R, PYTHON, AND MORE

Kaitlin Throgmorton, Justin DeMayo, and Sofia Fertuzinhos launched new training focused on developing computational skills for beginners. These courses include coding in Python and R, using the command line, accessing data from application programming interfaces, and implementing version control. Over 160 users from the Yale community attended seventeen classes, indicating strong interest across the medical campus.

Medical librarians also added options for asynchronous training, comprising two email courses and one webinar. These new modalities enable users to learn skills and concepts in a structured, self-paced format. Kaitlin's "How to Write a Data Management Plan" email course, which has over 370 subscribers, offers a step-by-step approach to creating the plans required for publishing grant-funded research. Dana Haugh's "How to Create an Academic Poster" email course offers a comprehensive guide to effectively communicating research in a poster presentation.

#### **MINDFULNESS OFFERINGS**

Megan Nance and Kyra Walker provided opportunities for library users to practice mindfulness, connect with their peers, and get creative while visiting the Medical Library. This year, visitors were encouraged to take a break with coloring pages, Lego building, and friendship bracelet-making stations in the library's lobby. For those who were extra busy, take-and-make kits were available. More than 300 visitors engaged with this year's mindfulness offerings.

#### **CUSHING CENTER UPDATE**

As part of a larger reimagining of the Cushing Center, users are encouraged to consider the Center's new mission statement when visiting and viewing this unique collection: "The mission of the Cushing Center is to inspire wonder about the human brain and its disorders, to educate visitors about the history of modern neurosurgery, and to respectfully steward the remains of patients contained within the Cushing Brain Tumor Registry."


